What is the deadline to apply for community support?

Fax and email applications will be treated like paper applications. Those received after November 1, 2010, will be returned to the applicant along with a letter that invites the organization to resubmit their request through the online application. All applications must be entered via the online application to be reviewed.

Do you accept requests for in-kind product donations?

Due to enforced restrictions, in place to protect the sales of our distributors in certain countries, we are limited in providing in-kind product donations?

Eligibility Criteria:

- Organization must be classified as 501(c)(3) tax exempt by the Internal Revenue Service
- Request must be received at least 30 days prior to the date needed
- Cannot be a repeat or multiple request
- Request for in-kind product will be used only for programming purposes in cities where Amway has corporate operations.

- Donation value does not exceed \$250

- Family reunions
- Sports fundraising events
